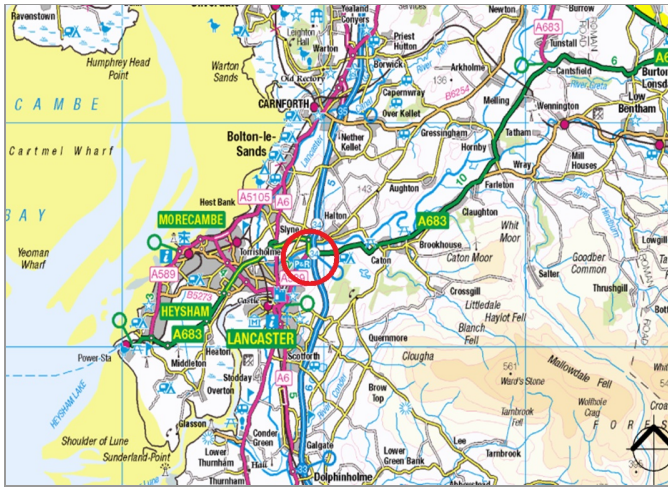

Location

The suite forms part of Lancaster Business Park, Caton Road, approximately 2 miles north of Lancaster city centre and immediately adjacent to Junction 34 of the M6 motorway. The location provides excellent connectivity to the wider North West, with direct access to the motorway network and the A683 linking into Lancaster and Morecambe.

Lancaster is an established administrative and university city serving North Lancashire and South Cumbria, with a broad economic base including professional services, education and public sector employment. Lancaster railway station provides regular services on the West Coast Main Line.

Nearby occupiers include a mix of regional and national businesses, with additional amenities available within the city centre and at nearby retail and trade locations.

Description

The building is set within well landscaped surroundings and having dedicated car parking offering occupiers a high profile position off Caton Road immediately adjacent to J34 of the M6:

- High quality office finish
- Suspended ceiling with LG3 lighting
- Carpet tiled floors
- Perimeter trunking for small power data & comms
- Glazed partitioned offices/meeting room
- Glazing to 3 elevations
- Air conditioning
- Passenger lift

The office suites extends to an approximate net internal area of 198 m² (2,136 ft²).

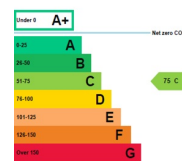
